- [15-0499-S1](#): Request for report to PLUM from DCP, LADBS, UFD, regarding response to 2018 Biodiversity report. Purpose is to create strategies for strengthening/expanding protected tree ordinance and protecting the urban canopy both private and public trees.
- [20-0844](#): Motion (Harris-Dawson) Amendment to LAMC to require LADBS inspectors to explain reasons for entering a property including requiring consent from the owner whether the property is occupied or not. Also adds the requirement of an inspection warrant if entrance is refused.
- [20-0843](#) (ITEM 6): Motion - Transfer funds (\$567k) for Summer Play LA - Rec & Parks will be resuming some youth programs this summer.
