Harbor Gateway North Neighborhood Board Meeting

Tuesday, August 10, 2021 Held via Zoom webinar

- 1) Welcome/introductions/roll call of Board members: Chair David Matthews called the meeting to order at 6:37 p.m. This was followed by the roll call of Board members which established that a quorum was present. David explained how stakeholders can indicate they wish to speak and unmute themselves, whether on a telephone or computer.
- 2) General public comment on non-agenda items that are within the Board's jurisdiction: District 1 stakeholder Fred Nichols asked that an Ad Hoc Election Committee be created before the next Board Election so that it can incorporate what the previous Committee learned from this past Board election.

Teresa Batson, City Planner from the Department of City Planning, said that the draft policy document for the Harbor Gateway Community Plan is available via their website and she asked that the HGNNC share the link with their stakeholders living in Districts 1 through 5 so that they can comment on the policy document before late September. The Story Map was already released and covers the proposed new zoning designations. The Department of City Planning is seeking input now on the policies and goals. 3) Reports

- a) Council District 8: There was no representative present.
- b) Council District 15: Field Deputy Caitlin Muldoon said that residents should email her with any questions or issues: caitlin.muldoon@lacity.org She said that Council File 21-0900-S29 is going before the Los Angeles City Council. It would create the Vermont Avenue/157th Street Lighting District to levy assessments for two LED street lights for the new small lot homes at 15812-15820 S. Vermont Avenue. Council File 20-0668 would ask for an extension on the time to present redistricting plans to October 29. Lisa Payne is the Mayor's Harbor Area representative until Johanna Rodriguez returns. The round-about pilot project for 126th Street and Ainsworth has been completed. Some clean ups of homeless encampments are possible now. Keep calling 311 for illegal dumping. use 1-800-ABANDON for abandoned vehicles, and 818-324-4823 for blocked driveways. Reporting creates statistics which help to focus services on the areas needing them. For as street closure permit, contact her for the procedure but allow thirty days for the process.
- c) Los Angeles County Supervisor, 2nd District: Ara An, Deputy for Constituent Engagement for Holly Mitchell, explained that she is one of three Deputies representing parts of the Harbor Gateway North area. On August 6 Supervisor Mitchell convened representatives of

all of the Neighborhood Councils within the 2nd District to hear about their issues. Vice Chair Joan Jacobs and Secretary Rosalie Preston represented the Harbor Gateway North NC.

- **d) Department of Neighborhood Empowerment:** There was no report as Neighborhood Empowerment Advocate Freddy Cupen-Ames was at another Neighborhood Council meeting.
- e) Harbor Alliance of Neighborhood Councils: The main topic of discussion at the August 4 meeting was the proposed updates to the Code of Conduct, which would require that all Committee members take training on the Code of Conduct.
