1. Welcome and Roll Call

3. Speaker from UCLA Homecare Healthcare Collaborative

Dr. Catherine Weaver and Mary Marfisse Clinic Program Director introduced their program and the services that they provide for the Homeless population. The UCLA Healthcare Collaborative group consist of a Physician, Nurse and Social Worker who go out in a Med Van and provide Lab services, Urine tests, Medication, Wound service and Urgent care treatment.

Kridel Truthbey stated most of the encampments are located along the 105 Freeway, SPA4, SPA6 and 8 and they usually visit once a week in the evening. Chair Barbara Tyson motioned that we work together with UCLA to provide Medical Services to our Neighborhood motion 2nd by Nakeisha Scott all committee agreed.

Possibly scheduling a Mobile Medical event at Avalon metro station.
