#### **Public Comment**

Comments from the public on other matters not appearing on the agenda that are within the Board's jurisdiction will be heard during the General Public Comment period. Please note that under the

Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Board meeting. Public comment is limited to two minutes per speaker, unless adjusted by the presiding officer of the Board.

### SB 411 Updates:

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.

The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time.

Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.

- (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph, to provide public comment until that timed public comment period has elapsed.
- (ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment.
- (iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.

# Harbor Gateway North Neighborhood Board Meeting

Tuesday, April 9, 2024 Held via Zoom webinar

Present: Joan Jacobs (Vice Chairperson), Rosalie Preston (Secretary), Keith Pitts (Treasurer), Laivern Frerichs (District 1), Nita Stonehocker (District 2), Dave Trejo (District 3), Arvie Powell (District 4), Eva Cooper Pace (District 5), Marvin Bell (District 6), Barbara Tyson-Frazier (District 7), Oscar Ruiz (District 8), Frankie Mays (Community Organization), and Craig Kusunoki (At Large Representative)

- 1) Welcome/call to order/Board roll call: In the absence of Chairperson Miguel Vazquez, Vice Chairperson Joan Jacobs called the meeting to order at 7:04 p.m. The roll call determined that a quorum was present.
- 2) General public comment on non-agenda items that are within the Neighborhood Council's subject matter jurisdiction: A stakeholder commented on the amount of graffiti that is being put up on walls near the Environmental Charter Middle School, 812 W. 165<sup>th</sup> Place. She was advised to report via 311.

### 3) Reports

- a) CD 15: Field Deputy Nicholas Chavez reported that the applications for speed humps closed fifteen minutes after the application period opened on March 21. Only twenty-five per each City Council District are accepted and then those are reviewed to see if they meet the criteria: be a residential street with no more than one lane in each direction, no fewer than 900 and no more than 10,000 vehicle trips per day, no more than an 8% grade, and a speed limit no higher than 30 miles per hour. Funding for speed humps in front of fifty elementary schools which have been identified as being in the high injury network was made available in the 2023-2024 fiscal year budget. He noted that the Merit Tract held a neighborhood watch meeting on April 2 which brought out over 100 residents. Councilmember Tim McOsker attended as well as Senior Lead Officer Robert Martinez and his supervisor Sgt. Jeff Spangler. The lights under the 110 freeway overpass at 168th Street have just been repaired. The CD 15 Clean Team has been monitoring that location for illegal dumping. The Council office checked out a reported illegal Airbnb in the Merit Tract. Nicholas and Planning Director Pamela Thornton attended the March 28 Planning and Land Use Committee meeting to discuss the next steps on the Harbor Gateway Community Plan. He has requested two large dumpsters for the May 4 Clean Up Day in District 7. If your block has excess palm fronds, call 311 to have them picked up. And use 311 for nearly every request for Los Angeles City services to help show the need for services in the Harbor Gateway North area, such as for clean up of illegal dumping and trash under the freeway overpasses. But then let Nicholas Chavez also know about your report: nicholas.i.chavez@lacity.org
- **b) LAPD**: Due to their schedules, neither Senior Lead Officer was able to be present. CD 15 Field Deputy Nicholas Chavez said that SLO Tyson Hamaoka was able to get the illegal dispensary at 119<sup>th</sup> Street and Main shut down. There is another illegal cannabis dispensary in the 800 W. block of Gardena Blvd. that LAPD Vice will be working on.
  - c) Mayor's Office: No one was present.
  - d) Los Angeles County Supervisor 2<sup>nd</sup> District: No one was present.
- e) Department of Neighborhood Empowerment: Neighborhood Empowerment Advocate Octaviano Rios reminded Board members that a revised Code of Conduct training is available via Cornerstone and needs to be completed by June 3 or Board members will lose their voting

privileges. There is also a new anti-bias gender identity training that must be completed. All Committee members must also read over and acknowledge the revised Code of Conduct. A recording of the Brown Act training that was offered to all Presidents/Chairs is available online for all Board and Committee members to view. Empowerla can offer assistance and support to Neighborhood Councils, such as event planning, assistance with designing flyers, and general outreach assistance, including how to create a QR code, setting up bus bench ads, and assistance with sending out bulk mailings. The City Clerk's office is seeking feedback on the revised Election Handbook by May 5. May 20 is the last date to submit Event Approval requests; June 1 is the last day for the Treasurer to write a check; June 20 is the last day to use the Neighborhood Council bank cards. Women leaders of Neighborhood Councils were honored at an event at City Hall on March 28.

# 4) Administrative motions

- a) Approval of the March 12, 2024, Board minutes: It was moved by Keith Pitts, seconded by Arvie Powell, and passed 13-0-0 to approve the minutes as presented.
- **b) Approval of the March 2024 Monthly Expenditure Report**: Treasurer Keith Pitts reviewed the various expenditures for March. The net amount available after all expenditures to date and encumbered funds is \$18,463.78. It was moved by Rosalie Preston, seconded by Marvin Bell, and passed 11-0-0 to approve the Monthly Expenditure Report.

## 5) Position letters

(Keith Pitts recused himself at 8:10 p.m., due to serving on the Los Angeles County Grand Jury and their work on issues related to the Department of Cannabis Regulation)

a) Approval of a letter of non-support for Cantasia retail cannabis, 12804 S. Hoover Street, Council File 21-0420-S49: Secretary Rosalie Preston explained that the Neighborhood Council Board members were informed via email by the Department of Cannabis Regulation on April 2 that various approved cannabis retail storefronts would be up for an annual license review, including The Drop/Therapeutic Health Collective (formerly known as Stone Age), 621 W. Rosecrans Blvd. However, a link provided in the email led to another list of PNC (Public Convenience and Necessity) applications for retail cannabis locations, including Cantasia at 12804 S. Hoover Street, though it was unclear if this was still an active application. Rosalie emailed the Department of Cannabis regulation for clarification but has not received a reply. Meanwhile, CD 15 Planning Director Pamela Thornton advised taking a position. The draft letter is one that was prepared in 2021 after Cantasia representatives had appeared at a September 16, 2021, Planning and Land Use Committee meeting and before the application seemed not to move forward. It was moved by Arvie Powell, seconded by Rosalie Preston, and passed 12-0-0 (Pitts recused) to approve sending of the letter and submitting a Community Impact Statement to the Council File.

(Keith Pitts returned to the meeting at 8:25 p.m.)

- b) Approval of support for Council File 23-0002-S115 (Wireless Telecommunications Facilities/Jurisdictional Control): Support for this Council File would show support for the City's position of opposing any State legislation that would undermine local control over its utility assets, including limits on the City's authority to regulate the placement of wireless facilities. It was moved by Marvin Bell, seconded by Keith Pitts, and passed 13-0-0 to support this Council File.
- c) Approval of support for Council File 22-0002-S123 (Stormwater and Watershed Management/Stormwater Capture Master Plan): This Council File supports State legislation that supports stormwater permitting reform that would allow the LADWP to expand its local

water supply. It was moved by Eva Cooper Pace, seconded by Rosalie Preston, and passed 13-0-0 to support this Council File.

# 6) Board business/announcements

- a) Reports from Committee Chairs: There were none.
- **b) Brief announcements from Board members:** Neighborhood Council Budget Day will be held at City Hall on June 15.

District 1 Representative Laivern Frerichs reported that the April 2 Merit Tract neighborhood watch meeting focused on an update on the John Ross, the squatter who had assaulted a mail carrier in their neighborhood. About 150 people attended. There was also discussion about creating an LAPD sub station on 190<sup>th</sup> Street, CD 15 Clean Team services, issues with illegal duping under the 168<sup>th</sup> Street overpass of the 110 freeway, and how Councilmember Tim McOsker is working with Assemblymember Mike Gipson on various resources that the state of California can provide, including through Caltrans. The next meeting will take place in May.

The meeting was adjourned at 8:38 p.m.

# Harbor Gateway North Neighborhood Board Meeting

Tuesday, April 23, 2024 116<sup>th</sup> Street School, 11610 Stanford Avenue

- 1) Welcome/call to order/Board roll call: In the absence of Chairperson Miguel Vazquez, Vice Chairperson Joan Jacobs called the meeting to order and welcomed those present at 7:15 p.m. A roll call determined that a quorum was present.
- 2) General public comment on non-agenda items that are within the Neighborhood Council's subject matter jurisdiction: A District 4 stakeholder asked when the Weingart Willows, 14032 S. Vermont Avenue, Project Homekey supportive housing, would be opening. The Neighborhood Council has been told it will be sometime in July.

# 3) Reports

a) CD 15: Field Deputy Nicholas Chavez said that he had left some pamphlets for LAHSA, the Los Angeles Homeless Services Authority, on the back table. Whenever you see homeless people, report via the la-hop portal: https://www.lahsa.org/portal/apps/la-hop/ The flyer also lists the Safe Parking locations for vehicles to park overnight. He noted that Council file 23-0278 regarding creative solutions to address lighting issues under Harbor Gateway freeway overpasses will be heard before the full City Council on April 26, so public comment in support is needed now. (The HGNNC already filed a Community Impact Statement in support on June 2, 2023). He said that EXODUS, is providing unarmed crisis response 24/7 in partnership with Southeast LAPD. He stressed the importance of using 311 (via telephone, online, or via the smartphone app) to report all needed City services, including street lights that are out or missing manhole covers. Council District 15 also has its own Clean Team to further address illegal dumping issues, such as at 117<sup>th</sup> Street and Athens Way. The Clean Team comes out to problem locations every three to four weeks, in addition to what the Bureau of Sanitation is doing. The Clean Team has a staff of two people and contracts with the Los Angeles Conservation Corps for the work. For major cases of illegal dumping, also email Nicholas at nicholas.i.chavez@lacity.org Regarding the 2024-2025 Los Angeles City budget, the Mayor has introduced her proposal. The Budget and Finance Committee will be reviewing it and making some changes before it goes to the full City Council for a vote by June 1. Councilmember Tim McOsker is a member of that Committee. There is an 80-page summary of the City budget and the fully detailed budget is also available online. He noted that the HGNNC submitted their budget letter via Council File 24-0600 on April 14, but individual stakeholders should make their priorities for spending known by submitting comment as well. In regards to 911 operators, Councilmember McOsker asked for refinements in the hiring process to allow for faster hiring and also the use of social media for advertising the vacant positions. Currently it is taking 42 weeks to complete the hiring process. Fifty new 911 operators are being trained currently, with thirty people submitting applications every day.

(Arvie Powell joined the meeting at 7:32 p.m.)

Nicholas said that when vacant lots are not being kept up, the owner or Trust will be notified and if the lot is not cleaned up, then the City Attorney will have to get involved. Council District 15 has given a list of problem vacant lots to the City Attorney already. One stakeholder commented that the bike lane on San Pedro Street limited the amount of vehicles that can drive on that street

and that the bike lane is not well-used. Nicholas said that the Department of Transportation could do a study to evaluate the situation.

**b)** LAPD: No one was present.

4) Speaker: Emergency Management Department-How to prepare your family and pets for any type of major emergency; sign up to be a block leader: Brenda Rodriguez, Emergency Management Coordinator, explained that the Emergency Operations Center (EOC) is a 84,000 square foot facility in downtown Los Angeles. The Center was activated during the COVID-19 pandemic and in service for over 1,000 days, and also during the Summit of the Americas and during times of extreme heat. They serve as the coordinating center during disasters impacting the City, such as earthquakes, tsunamis, and Santa Ana winds. The City of Los Angeles has over 4 million residents, with 6 million people inside City boundaries during the workday. The City covers 471 square miles, with only 9,888 LAPD officers and 3,246 firefighters. So individual residents need to be prepared to take care of themselves and their families during major emergencies. Build your emergency kit now—include copies of important documents (or load them on a USB drive), sturdy boots or shoes, water, and an emergency radio. Organize your block, apartment building, or condominium through the Ready Your Neighborhood program so that during the first 60 minutes after the disaster as many lives as possible can be saved.

(Oscar Ruiz entered the meeting at 7:50 p.m.)

Step 1 - ensure your personal safety

Step 2 - check on your loved ones

Step 3 - follow safety procedures, such as utility shut offs, if needed

Step 4 - fill your bathtub with water

Step 5 - put the Help or OK sign on your front door

Step 6 - put out your fire extinguisher where neighbors can see it

Step 7 – go to your neighborhood's designated gathering site

Step 8 – form teams to carry out necessary functions to support your neighborhood during the emergency, such as communications, health care, shelter, and utility safety checks During RYLAN meetings for your block or neighborhood, create a list of skills and equipment that neighbors have, such as nursing, construction, generators, ham radio operator, languages spoken that can be utilized during emergencies to help neighbors. There is also a RYLAN program for businesses.

5) Speaker: Bureau of Sanitation-how to get homeless encampments cleaned up: Nick Fuentes, Superintendent of Livability Services, which oversees illegal dumping and the CARE programs, introduced CARE staff members Juanita Bell, Rosemary Cabrera, and Warren Tan, Senior Inspector. The Bureau currently has 140 vacancies and they are trying to lease a property to handle some of their equipment and supplies. If your illegal dumping request is not picked up by the designated date, email CD 15 Field Deputy Nicholas Chavez with the Service Request number and photos, if possible, so that he can follow up. Be descriptive of the location if there is not an exact address. For encampment clean ups, LASAN's responsibility is removing personal property, health hazards, and trash and debris. LAPD handles any law enforcement issues at the site, while LAHSA (Los Angeles Homeless Services Authority) staff work with the homeless individuals to find housing and services they may need. LASAN participates in four different types of responses to encampments: Inside Safe (Mayor Karen Bass's initiative), CARE+ which requires pre-clearance posted notices and includes power washing of the public right of way after a clean up, CARE which are clean ups which do not require posting and focus on removing trash that is publicly visible, and inter-agency support for the removal trash and health hazards such as needles and chemicals when RVs are removed from streets, along with the Department of Transportation, LAPD, and HOPICS, one of the service providers under LAHSA. Clean ups are

scheduled in consultation with Council District staff who determine the order of clean ups within their Districts. Service providers are included to encourage the homeless to accept services and housing. There is documentation of what is cleaned up. LASAN only cleans in the public right of way of the City of Los Angeles and not in parks, Caltrans areas, or on private property. The City Administrative Officer leads the coordination of RV removals. For homeless camping on Caltrans property, use 311 to report. Council Districts will work with Caltrans on this issue and also with homeless issues in the unincorporated L.A. County area. The goal is to help the homeless to find permanent solutions and not just to drive them to another location, as well as to remove trash and health hazards, such as human waste, needles, gasoline, and aerosols. Personal property that is not taken away by the owner is stored and can be returned at a later time. For homeless encampments on Caltrans property, residents can also report directly online via <a href="https://csr.dot.ca.gov/">https://csr.dot.ca.gov/</a> If there is no response after three weeks, call the office of Assemblymember Mike Gipson or Assemblymember Reggie Jones-Sawyer. Using the NavigateLA website can show the boundaries for Caltrans and private properties within the City of Los Angeles.

(Barbara Tyson-Frazier left the meeting at 8:40 p.m.)

#### RESOLUTION

WHEREAS, any official position of the City of Los Angeles, with respect to legislation, rules, regulations, or policies proposed to or pending before a local, state, or federal governmental body or agency must have first been adopted in the form of a Resolution by the City Council; and

WHEREAS, California is currently experiencing a housing and affordability crisis that disproportionately affects low-income households and historically disadvantaged communities. For example, 55% of very low-income households, and 23% of low-income households, are spending over half of their income on rent, compared to 6% of moderate-income households; and

WHEREAS, although the lack of affordable housing stock contributes to the lack of affordability, market distortions make the existing crises more pronounced in rent burdened communities. Despite owning 3.6% of apartments and 1.6% of rental homes nationally, institutional investors can still have adverse impacts. A Washington Post report in 2022 found that some zip codes in Los Angeles, Oakland, Sacramento, San Francisco, San Jose, and San Diego saw an increase in investors purchased properties, with one zip code in Los Angeles seeing as many as 48% of properties sold that year being bought by investors; and

WHEREAS, the same Washington Post report found that "30 percent of home sales in majority Black neighborhoods went to investor." The U.S. Department of Housing and Urban Development's Office of Policy Development and Research has noted that institutional investors have concentrated their purchases in low-income communities throughout the U.S., and were 68% more likely to file for eviction, compared to small landlords; and

WHEREAS, California residents have experienced the effects of this steady increase of investorowned properties. In San Diego, one group bought 66 relatively low-rent apartment buildings that resulted in rent increases between 7% and 201%; and

WHEREAS, as institutional investors, with vast resources, continue to purchase property in California, they can potentially limit the ability for individuals and families to compete for the limited housing stock available. The growing role of algorithms as a tool for property owners to adjust their rental or sale price, and consolidation of properties at the zip code level requires scrutiny to ensure that the housing market is not being manipulated; and

WHEREAS, Assembly Bill (AB) 2230 (Bennett), introduced on February 8, 2024, would clarify that California's anti-trust laws can be applied to anti-competitive practices occurring in residential housing, and would clarify that City Attorneys may investigate and prosecute anticompetitive behavior; and

WHEREAS, California anti-trust law already makes it illegal for two or more persons to restrain trade, fix prices or production, or reduce competition, and AB 2230 would ensure proper enforcement against anticompetitive practices in housing;

**NOW, THEREFORE, BE IT RESOLVED,** that by the adoption of this Resolution, the City of Los Angeles hereby includes in its 2023-2024 State Legislative Program SUPPORT for AB 2230 (Bennett) which would clarify that California's anti-trust laws can be applied to anti-competitive practices occurring in residential housing, and would clarify that City Attorneys may investigate and prosecute anticompetitive behavior.

# RESOLUTION RULES, ELECTIONS, INTERGOVERNMENTAL RELATIONS

WHEREAS, any official position of the City of Los Angeles, with respect to legislation, rules, regulations, or policies proposed to or pending before a local, state, or federal governmental body or agency must have first been adopted in the form of a Resolution by the City Council; and

WHEREAS, according to the California Child Welfare Council, human trafficking is a \$32 billion global industry, involving over 100,000 children in the United States; and

WHEREAS, within the United States, California consistently ranks number one in the number of human trafficking cases reported to the National Human Trafficking Hotline; and

WHEREAS, the Federal Bureau of Investigation has identified Los Angeles as one of the nation's high intensity child prostitution areas; and

WHEREAS, California law requires sex offender registration for those convicted of a wide variety of sexual offenses against minors; and

WHEREAS, California law requires sex offender registration for those engaged in specific "consensual" sex acts with a minor, including oral copulation, sodomy, and sexual penetration with a foreign object, if the offender is more than 10 years older than the minor; and

WHEREAS, Senate Bill (SB) 1128 (Portantino), introduced on February 13, 2024, would require those convicted of engaging in unlawful sexual intercourse with a minor who is more than three (3) years younger than the offender, or if the offender is over 21 years of age and the minor is under 16 years of age, be required to register as a sex offender for ten (10) years; and

WHEREAS, SB 1128 would require lifetime registration as a sex offender for those convicted of engaging in unlawful sexual intercourse with a minor who is more than three (3) years younger than the offender, or if the offender is over 21 years of age and the minor is under 16 years of age, if the offender received a prior conviction for the same offense;

NOW, THEREFORE, BE IT RESOLVED, that by the adoption of this Resolution, the City of Los Angeles hereby includes in its 2023-2024 State Legislative Program SUPPORT for SB 1128 (Portantino) which would deter the sexual exploitation of children and create more consistent consequences for those who engage in unlawful sexual acts with a minor.

At a regular meeting held on May 16, 2023, the PLUM Committee considered a report from the DCP and a Resolution (McOsker – Harris-Dawson) relative to extending the provisions of Ordinance No. 187552 imposing temporary interim regulations prohibiting the issuance of all permits and certificates of occupancy associated with the establishment or the expansion of all trucking-related uses on all industrial land in the Wilmington-Harbor City Community Plan Area, except for the area east of Alameda Street and the Wilmington Industrial Park area located south of G Street and east of Broad Avenue, for an additional extension period of one year.
