Public Comment

Comments from the public on other matters not appearing on the agenda that are within the Board's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Board meeting. Public comment is limited to two minutes per speaker, unless

adjusted by the presiding officer of the Board.

SB 411 Updates:

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.

The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time.

Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.

- (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph, to provide public comment until that timed public comment period has elapsed.
- (ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment.
- (iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.

Harbor Gateway North Neighborhood Board Meeting

Tuesday, March 11, 2025 Held via Zoom webinar

Present: Joan Jacobs (Vice Chair), Rosalie Preston (Secretary), Majenni Nixon (Treasurer), Laivren Frerichs (District 1), Nita Stonehocker (District 2), Dave Trejo (District 3), Arvie Powell (District 4), Eva Cooper Pace (District 5), Marvin Bell (District 6), Oscar Ruiz (District 8), Frankie Mays (Community Organization), Jackie Jackson (Youth Advocate), and Craig Kusunoki (At Large Representative)

Absent: Barbara Tyson-Frazier (District 7), Finesse Simmons (Youth Representative)

- 1) Welcome/call to order/Board roll call: Vice Chairperson Joan Jacobs called the meeting to order at 7:07 p.m. The roll call determined that a quorum was present.
- 2) General public comment on non-agenda items that are within the Neighborhood Council's subject matter jurisdiction: District 3 Stakeholder Erica Payne noted that a lot of homeless people are again living along the railroad tracks, including at the location near her neighbor's back fence where a homeless man previously started a fire near a power pole.

3) Reports

a) LAPD: Senior Lead Officer Tyson Hamaoka said that he patrols the area from Imperial Highway to 120th Street and from Figueroa to Central Avenue in Basic Car 18A63. He said that he and Officer Martinez were reassigned to work in the Palisades after the fire. He said that his supervisor Sgt. Jeff Spangler is still there until the end of March. Crime is down in his patrol area. In the last two weeks there have been two stolen vehicles, two aggravated assaults, and one_____. The main corridors are clear of parked RVs at the moment. The 7 Eleven at 600 E. Imperial Highway has closed. Officer Hamaoka is in touch with the property owner, who is cooperative. An independent vendor will be hired to remove vehicles that are parked in the lot.

(Eva Cooper-Pace and Jackie Jackson entered the meeting at 7:15 p.m.) The property owner is looking for a new tenant. Officer Hamaoka also discussed a recent event where during his removing of RVs from Central Avenue, a stakeholder asked him not to remove a vehicle that had expired registration, and said he was a HGNNC Board member. Officer Hamaoka said that he must enforce the laws equally even if they impact local residents or Board members. Frankie Mays thanked Officer Hamaoka for the recent clean up of a homeless encampment and trash at Imperial and Main Street. Rosalie Preston asked about the status of the vacant buildings on the southwest corner of 120th and Central Avenue where a new apartment building is supposed to be built and the old buildings were to have been demolished in December. Officer Hamaoka said that the property owner is cooperative but having difficulty securing funding to carry out the demolition. Officer Hamaoka said he would be off work for the next two weeks due to knee surgery.

- b) Council District 15: New Field Deputy Rudy Martinez introduced himself. He has worked on getting clean ups along the 105 freeway between Vermont Avenue and Figueroa Street. Union Pacific Railroad is supposed to put up some type of deterrent barrier to discourage future illegal dumping. In regards to the encampment along the 110 Freeway at Alondra, on Caltrans property, a clean up is being organized for the end of March. He has also been working on clean ups of illegal dumping along 117th Street from Main Street to Avalon. A clean up of the homeless encampment on Estrella north of 135th Street is being organized with LAHSA and Caltrans. He is aware of street light issues on Athens Blvd. and other parts of the Athens on the Hill area. Nita Stonehocker said that another area of homeless encampments is east of the 110 Freeway and north of Redondo Beach Blvd. Arvie Powell noted that most of the street lights are out on Estella north of 135th Street, which encourages homeless encampments and illegal dumping. District 3 Stakeholder Erica Payne again mentioned the homeless encampments along the Union Pacific railroad tracks south of Rosecrans Park. Rudy said to let him know of issues via his work cell: 213-335-0863. Stakeholders and Board members can text him and send photos of issues.
- c) Other elected officials: Kasie Hervey, Deputy for Constituent Engagement for 2nd District Supervisor Holly Mitchell, said that the next Racial Justice will take place at the New Life Church, 2600

- S. La Brea, on Friday March 21, which will be a walk in West Adams to observe and discuss how to create an equitable mobility system for pedestrians, bicyclists, drivers, and those using public transit. Last month the talk was on the legacy of eminent domain to create new freeways or widen them, with the impact on black and brown communities. The recording of that talk can be found on Supervisor Mitchell's YouTube channel. The budget presentations by each Los Angeles County Department have now concluded. However, Supervisor Mitchell encourages in person attendance at the regular Board of Supervisors meetings.
- d) Department of Neighborhood Empowerment: Helena Doub, Neighborhood Empowerment Advocate for Harbor Gateway North, reminded the Neighborhood Council that a vote needs to be taken to renew the HGNNC Zoom account license for the 2025-2026 fiscal year. It will cost just under \$200 for the year. The Department has a Google Drive Public Folder for key resources, which can be accessed via the EmpowerLA website under "Neighborhood Council Resources." The LA Civil Rights Department is hosting a Women in Governance virtual panel on March 17, with Councilmembers Hutt, Jurado, and Padilla. In regards to the Neighborhood Council Board elections, registration for a vote-by-mail ballot began on January 24 and will end on Mon. March 17 at 11:59 p.m. The deadline to submit ballots by either U.S. mail or the drop box at the Rosecrans Recreation Center is Tues. March 25. Helena also said that many Neighborhood Councils have raised the issue of how to inform their stakeholders of their rights in relation to immigration issues. She noted that EmpowerLA has created an informational YouTube in collaboration with the Community Investment for Families Department's Office of Immigrant Inclusion and Language Access (OIILA), the Los Angeles Public Library, and other City and community organization partners: https://www.youtube.com/watch?v=YFjTc6bya64 Other information is listed on the website: https://communityinvestment.lacity.gov/articles/know-your-rights-immigrants-rights-andresources She reminded the Neighborhood Council not to put their name or logo on the Know Your Rights flyers, though they can be posed with the information.
- e) **HGNNC Board election-vote-by-mail:** Outreach/Communications Committee Chair Frankie Mays said that the City Clerk has informed the Neighborhood Council that 79 vote-by-mail applications have been received to date.
- f) Updates on 2024-2025 Board goals/priorities: Rosecrans Avenue medians planting with trees-no update. Coffee with a Cop--Frankie Mays and Nita Stonehocker said that there is still no update. Increasing stakeholder engagement via van tour of HGNNC--no update. Cultural event involving youth—District 5 stakeholder Lu Watson said that she and District 5 representative Eva Cooper Pace will be discussing organization of the Athens on the Hill Juneteenth event at which the cultural event will be held. Farmers' Markets—Majenni Nixon said that the Venice Family Clinic is still hosting food giveaways on the second and fourth Tuesdays of each month. She has not yet had time to visit the two community gardens within the HGNNC boundaries. Updating website—Rosalie Preston said that she had sent information on the Westside Neighborhood Council website to webmaster Aaron DeVandry so that he could consider re-designing the HGNNC website with a similar arrangement of tabs and design. The Know Your Rights information was posted on the HGNNC website home page and also to the Resources page under a new section called "Immigration."
- 4) Approval of revisions to the HGNNC Standing Rules, as recommended by the Bylaws Committee: At the February 11 Board meeting, the current draft of the HGNNC Standing Rules with the four proposed changes was presented, with only one controversial as the Bylaws Committee was divided over the wording on having a Consent Calendar on the Board agenda (Standing Rule 3). Since then, the Neighborhood Empowerment Advocate Helena Doub has sent the Board advice on the issue. Majenni Nixon screen-shared that advice, which suggested that the use of "may" as opposed to the current word "shall" would allow more flexibility as most agendas do not have items that are suitable for a Consent Calendar. It was moved by Rosalie Preston, seconded by Marvin Bell, and passed 12(Bell, Cooper-Pace, Frerichs, Jackson, Jacobs, Kusunoki, Mays, Nixon, Powell, Preston, Ruiz, Trejo)-1(Stonehocker)-0 to approve the four changes.

5) Comment letters

a) Approval of letter on 2025 permit review for California Waste Services, 621 W. 152nd Street, as recommended by the Planning and Land Use Committee: The draft letter was screen-shared and

read out. Planning and Land Use Committee member Lu Watson asked that the fifteen bullet points be numbered. District 3 Representative Dave Trejo wondered if there was a realistic chance that all of the recommendations would be incorporated into the new five-year permit. Rosalie Preston said that the letter would serve as a statement of key issues impacting stakeholders and would be sent to a number of other oversight agencies. It was moved by Eva Cooper-Pace, seconded by Rosalie Preston, and passed 13 (Bell, Cooper-Pace, Frerichs, Jackson, Jacobs, Kusunoki, Mays, Nixon, Powell, Preston, Ruiz, Stonehocker, Trejo)-0-0 to support the letter with the bullet points numbered.

- b) Approval of HGNNC 2025-2026 City budget priorities letter: The draft letter was screenshared. District 4 Representative Arvie Powell asked that more money be added to the City budget to speed up the repairs of the street lights that are out, add "no illegal dumping" signs along Hoover Street from El Segundo to Rosecrans and on Estrella north of 135th Street, and similar signs in the District 4 alleys that are often illegal dumping locations. It was moved by Rosalie Preston, seconded by Arvie Powell, and passed 13 (Bell, Cooper-Pace, Frerichs, Jackson, Jacobs, Kusunoki, Mays, Nixon, Powell, Preston, Ruiz, Stonehocker, Trejo)-0-0 to approve the letter with the additions.
- 6) Consideration of support for Council File 24-1580 (Oil Well Acid Maintenance/Public Notification/AB3233): Councilmember McOsker co-sponsored this motion, which would create an interim control ordinance which would halt the practice of oil well acid maintenance and create a timeline for implementation of a new oil ordinance per AB3233. It was moved by Nita Stonehocker, seconded by Eva Cooper-Pace, and passed 13 (Bell, Cooper-Pace, Frerichs, Jackson, Jacobs, Kusunoki, Mays, Nixon, Powell, Preston, Ruiz, Stonehocker, Trejo)-0-0 to support the Council File.

7) Administrative motions

- a) Approval of the February 11, 2025, Board minutes: It was moved by Majenni Nixon, seconded by Frankie Mays, and passed 12(Bell, Cooper-Pace, Jackson, Jacobs, Kusunoki, Mays, Nixon, Powell, Preston, Ruiz, Stonehocker, Trejo)-1(Frerichs)-0 to approve the minutes as submitted.
- b) Approval of the February 25, 2025, Special Board minutes: It was moved by Majenni Nixon, seconded by Arvie Powell, and passed 11(Bell, Cooper-Pace, Frerichs, Jackson, Jacobs, Kusunoki, Mays, Nixon, Powell, Preston, Ruiz)-2(Stonehocker Trejo)-0 to approve the minutes as submitted.
- c) Approval of \$600 to SoCal Shred for the February 1 voter registration event: City Clerk Funding asked for a separate vote on this expenditure by credit card, even though it had previously been approved as part of the Board election outreach budget. It was moved by Majenni Nixon, seconded by Arvie Powell, and passed 13 (Bell, Cooper-Pace, Frerichs, Jackson, Jacobs, Kusunoki, Mays, Nixon, Powell, Preston, Ruiz, Stonehocker, Trejo)-0-0 to approve the expenditure.
- d) Approval of \$149.99 to McAfee for virus protection for office computer and laptop for one year: It was moved by Rosalie Preston, seconded by Frankie Mays, and passed 13 (Bell, Cooper-Pace, Frerichs, Jackson, Jacobs, Kusunoki, Mays, Nixon, Powell, Preston, Ruiz, Stonehocker, Trejo)-0-0 to approve the expenditure.

9) Board business/announcements

a) Reports from Committees: The Planning and Land Use Committee met on March 4 and finalized the draft comment letter on the California Waste Services 2025 permit review. The Final EIR on the proposed Prologis warehouse is expected to be released in April or May. The Rexford warehouse which will have the office

The Finance Committee will meet to review two Neighborhood Purposes Grant requests and to update the 2024-2025 HGNNC budget.

b) Brief announcements from Board members: The next General Membership meeting will be held on Tues. April 22, with a location to be determined. Metro will be speaking on the current status of the Fast Lanes project along the 105 freeway, which will impact District 6, 7, and 8 stakeholders due to widening of the freeway.

The meeting was adjourned at 9:07 p.m.



Re: Gardena Blvd. public safety and quality of life issues

Dear Mayor Bass:

On April 8, the Harbor Gateway North Neighborhood Council Board voted x-x-x to submit this comment letter to express our concerns about the public safety and quality of life issues along Gardena Boulevard between Vermont Avenue and Figueroa Street in the Harbor Gateway North community. Along this corridor are four institutions that serve children and families, including Gardena Elementary School, Environmental Charter Middle School Gardena, The Boys and Girls Club Gardena and Venice Family Clinic and also many multi-family residences and a number of small-businesses.

Despite past efforts by individual agencies and community members, the area continues to suffer from persistent challenges that have escalated over the past year. The conditions described below are impacting hundreds of students, parents, school staff, and nearby residents and businesses on a daily basis.

Public Drinking and Drug Use

Public intoxication occurs daily at the Gardena Blvd/Vermont Avenue G Trans bus stop, Young's Market, Community Market, and the corner of 165th Place and Ainsworth Street, along the routes to the youth-serving institutions. These areas make students, families, and public transit riders feel unsafe. Reports include urination in public, verbal harassment of women and children, use of nitrous oxide balloons, and marijuana smoke exposure.

Gang Activity

Known G13 locations include the barber shop at 836 W. Gardena Blvd., the smoke shop on Gardena Blvd, and specific residential addresses. Youth who should be in school are frequently

seen loitering in these areas. Graffiti tagging at these sites is constant and often follows gatherings at these locations.

Graffiti Vandalism

Graffiti is a near-daily occurrence in alleys, fronts and sides of businesses, and residential properties, especially around 165th Place and Ainsworth Avenue. For example, over 500 instances of graffiti have been documented by Environmental Charter Middle School staff in recent months alone.

Illegal Dumping

Dumping regularly occurs near apartment buildings on 833 W. 165th Place, 16399 S Ainsworth Street, 813 W 167th Street, and near Estrella Avenue and the Gardena Blvd. underpass of the I-110 freeway.

Street Cleanliness

The appearance of Gardena Blvd. suffers from a lack of street sweeping, sidewalk steam cleaning, and untrimmed palm trees.

Parking Violations and Vehicle Storage

Local auto-repair related businesses are using public streets and sidewalks for vehicle storage, including on Menlo Ave across from the Boys and Girls Club and Estrella Avenue near Gardena Elementary School. These practices reduce parking for those living along Gardena Blvd. and for business customers as well as creating visibility hazards.

RECOMMENDED ACTIONS:

Mayor's Office:

- -Launch a coordinated, multi-agency initiative that includes LAPD, the City Attorney, Sanitation, Youth Development, and CD15 to address conditions along Gardena Blvd.
- -Restore or expand funding for youth intervention programs that prevent gang involvement.
- -Address street sweeping, sidewalk cleaning, and regular (quarterly) trimming of queen palms. If City resources are limited, consider a partnership with the City of Gardena, which has previously offered support.
- -Improve transparency and data sharing from 311 to LAPD, the Neighborhood Council, and schools.

Council District 15:

- -Conduct a walk-through of the Gardena Blvd. corridor with the Neighborhood Council, staff of the two schools, Boys and Girls Club, Venice Family Clinic, and other key stakeholders.
- -Advocate for increased and consistent LAPD/security/non-profit presence at identified hotspots.
- -Facilitate formal collaboration between LAPD and Gardena PD, which has already shown willingness to support.
- -Install cameras in areas of persistent illegal activity and vandalism.
- -Ensure enforcement of parking violations along the Gardena Blvd. corridor.
- -Engage with apartment owners, property managers, and nearby homeowners and businesses to promote education for themselves and their tenants on the use of 311 for illegal dumping.

-Collaborate with social services to support unhoused individuals and those struggling with substance abuse, especially near schools, the Boys and Girls Club, and GTrans bus stop.

LAPD:

- -Increase proactive foot patrols and officer engagement in high-activity zones.
- -Assign a dedicated contact for non-emergency concerns who can respond in a timely and coordinated fashion.
- -Collaborate with gang intervention and non-emergency outreach programs to support prevention.
- -Attend Neighborhood Council meetings regularly to hear about and address community concerns for the issues referred to and also for response times to both 911 and non-emergency calls for service.

City Attorney's Office:

- -Investigate properties with repeated illegal activity and pursue nuisance abatement if needed.
- -Assist with property owner accountability and 311 awareness campaigns in multi-unit residential buildings.

The current issues along Gardena Blvd. are a matter of the safety of students and stakeholders using Gardena Blvd. businesses, living nearby, and using public transportation. We stand ready to partner with City agencies, the Los Angeles Police Department, and unarmed crisis response to develop appropriate resources to improve the current situation and on-going quality of life issues for all impacted stakeholders along this corridor.

PESA provides these youth with mental health support, career training and educational support. These youth require supportive services for the purchase of food, household items, clothing, school supplies and at times temporary housing. At times their families need this support as well.

PESA does not have an adequate funding stream to support the needs of these youth residing within the boundaries of this neighborhood council concerning supportive supplies. 
