Public Comment

Comments from the public on other matters not appearing on the agenda that are within the Board's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Board meeting. Public comment is limited to two minutes per speaker, unless

adjusted by the presiding officer of the Board.

SB 411 Updates:

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.

The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time.

Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.

- (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph, to provide public comment until that timed public comment period has elapsed.
- (ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment.
- (iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.

- 1) Welcome/call to order/Board roll call: Chairperson Joan Jacobs called the meeting to order at 7:08 p.m. The roll call determined that a quorum was present.
- 2) Seating of the new Board by Helena Doub, Neighborhood Empowerment Advocate, Department of Neighborhood Empowerment: NEA Helena Doub administered the oath of office to the newly elected Board members.
- 3) General public comment on non-agenda items that are within the Neighborhood Council's subject matter jurisdiction: Barbara Stanton, Executive Director of EECI (Entrepreneur Educational Center Inc.), welcomed the Board and stakeholders to EECI's space, which was remodeled thanks to a grant from former State Senator Steven Bradford. EECI helps people learn the skills to develop a small business or to learn skills to become a certified diver. Alonzo Williams is one of their instructors for the entrepreneurship program. Her mother is Ozie Gonzaque, who is now 100 years old; she served on the Los Angeles Housing Commission for 18 years, including 11 years as Chair.

(Marvin Bell entered the meeting at 7:13 p.m.)

4) Reports

- a) LAPD: Neither Senior Lead Officer Robert Martinez or Senior Lead Officer Tyson Hamaoka was able to be present due to having been assigned to two clean ups in the morning and not given permission to work overtime. Senior Lead Officer Robert Martinez had sent a brief report summarizing recent activities.
- **b)** Council District 15: CD 15 Field Deputy for the Harbor Gateway area, Rudy Martinez, was ill, so could not attend the in-person meeting. Board and stakeholders were reminded of his new email which is rudy.e.martinez@lacity.org
- c) Other elected officials: In place of Kasie Hervey, Constituent Services for 2nd District Supervisor Holly Mitchell, Ara An attended. Supervisor Mitchell was elected in 2021, the year when Juneteenth became a Federal holiday. She started an annual Juneteenth celebration which this year will be held in Roy Campanella Park, 14812 S. Stanford Avenue. Other programs will be held there throughout the summer, such as urban gardening with Crop Swap, ocean education with the Black Surfers Collective, diversity hair care, bicycle safety, and painting and mindfulness workshops.

Moises "Jun" Aglipay, Assemblymember Mike Gipson's office, brought flyers for the August 29 movie showing of "Respect my Crown" in Carson.

d) Department of Neighborhood Empowerment: Helena Doub, Neighborhood Empowerment Advocate for Harbor Gateway North, said that she will create an email group for the Board so that she can send out Neighborhood Empowerment information. Boardmember orientation will be led by the Civic Leadership Division of the Department. The period for amending the HGNNC Bylaws will begin in September with a Bylaws template provided. She will attend the Board's Retreat and said that DONE can assist with arranging for speakers and having Council District 15 present. The Board's Annual Assessment is due. A survey on the recent Board elections will be sent out by email.In response to a stakeholder's question about what the requirements are for being a Boardmember, she said that it is taking

the five required trainings via Cornerstone, attending the Board meetings, and being an advisory body for the neighborhood to the City of Los Angeles.

(Clifford McClain entered the meeting at 7:35 p.m.)

5) Appointments to vacant seats

- a) Vice Chairperson: Alonzo Williams had expressed interest in being appointed to the seat. He had run for the At-Large Representative seat. He has lived in the Athens on the Hill community for the past 40 years. He is editor of the online Hub City Legend newsletter/newspaper, which covers news of Compton and surrounding areas in both physical and digital format. He is the President of the Compton Entertainment Chamber of Commerce. Addressing the issue of illegal dumping is one of his big concerns. It was moved by Marvin Bell, seconded by Clifford McClain, and passed 12(Bell, Cooper-Pace, Jackson, Jacobs, Johnson, Mays, Nixon, Powell, Preston, Robinson, Trejo, Tyson-Frazier)-0-0, with McClain ineligible, to appoint Alonzo Williams as Vice Chairperson.
- b) District 2 Representative: Bart Bidlingmeyer said that he has lived in the District 2 area for six years. He enjoys his neighbors and the community and would like to be a force for good and to create a good place for his two young children to live. It was moved by Rosalie Preston, seconded by Marvin Bell, and passed 12(Bell, Cooper-Pace, Jackson, Jacobs, Johnson, Mays, Nixon, Powell, Preston, Robinson, Trejo, Tyson-Frazier)-0-0, with McClain ineligible, to appoint Bart Bidlingmeyer as the District 2 Representative.
- c) Community Organization Representative: Jeremy Guyton ran for District 6 Representative and said he is interested in being appointed to the Community Organization Representative seat. He is a third-generation homeowner, with his grandparents moving in 1963 to Menlo Avenue in District from Millport, Alabama. He runs a non-profit from his home, a.l.t. ^home, a cultural archive and community gathering space, with one goal being to document the backgrounds of those in the neighborhood who, like his grandparents, also moved there during the Great Migration from the South. He has already documented three neighboring families and will be expanding to other nearby blocks. It was moved by Marvin Bell, seconded by Ronald Robinson, and passed 12(Bell, Cooper-Pace, Jackson, Jacobs, Johnson, Mays, Nixon, Powell, Preston, Robinson, Trejo, Tyson-Frazier)-0-0, with McClain ineligible, to appoint Jeremy Guyton to the Community Organization Representative seat.

7) Community Impact Statements/comment letters

a) Statement of support of immigrants in the Harbor Gateway North community: District 3 Representative Dave Trejo had drafted the letter, projected it, and read it out. It was moved by Majenni Nixon, seconded by Ronald Robinson, and passed 10(Cooper-Pace, Jackson, Jacobs, Johnson, Mays,

Nixon, Preston, Robinson, Trejo, Tyson-Frazier)-0-2(Bell, Powell), with Bidlingmeyer, Guyton, McClain, and Williams ineligible, to approve the letter.

b) Support for Council File 25-0694 (requests the City Attorney to prioritize immediate legal protection to protect the civil rights of residents): It was moved by Rosalie Preston, seconded by Barbara Tyson-Frazier, and passed 10(Cooper-Pace, Jackson, Jacobs, Johnson, Mays, Nixon, Preston, Robinson, Trejo, Tyson-Frazier)-1(Bell)-1(Powell), with Bidlingmeyer, Guyton, McClain, and Williams ineligible, to approve support for the Council File.

8) Administrative motions

- a) Approval of the June 10, 2025, Board minutes: It was moved by Eva Cooper-Pace, seconded by Marvin Bell, and passed 12(Bell, Cooper-Pace, Jackson, Jacobs, Johnson, Mays, Powell, Preston, Nixon, Robinson, Trejo, Tyson-Frazier)-0-0, with Bidlingmeyer, Guyton, McClain, Williams ineligible, to approve the minutes as submitted.
- b) Approval of the June Monthly Expenditure Report: Treasurer Majenni Nixon reviewed the report. \$8,344.22 remained from the 2024-2025 fiscal year budget and will be rolled over to add to the 2025-2026 budget later in the summer. It was moved by Rosalie Preston, seconded by Marvin Bell, and passed 12(Bell, Cooper-Pace, Jackson, Jacobs, Johnson, Mays, Powell, Preston, Nixon, Robinson, Trejo, Tyson-Frazier)-0-0, with Bidlingmeyer, Guyton, McClain, Williams ineligible, to approve the Expenditure Report.
- c) Approval of increased rent for office 205 to \$710 per month: Armonia Investments has asked for a 3% increase in the monthly rent for the office at 555 W. Redondo Beach Blvd. It was moved by Marvin Bell, seconded by Barbara Tyson-Frazier, and passed 12(Bell, Cooper-Pace, Jackson, Jacobs, Johnson, Mays, Powell, Preston, Nixon, Robinson, Trejo, Tyson-Frazier)-0-0, with Bidlingmeyer, Guyton, McClain, Williams ineligible, to approve the expenditure.
- d) Approval for continuing agreement for website services from The Mailroom, at \$200 a month: It was moved by Rosalie Preston, seconded by Marvin Bell, and passed 12(Bell, Cooper-Pace, Jackson, Jacobs, Johnson, Mays, Powell, Preston, Nixon, Robinson, Trejo, Tyson-Frazier)-0-0, with Bidlingmeyer, Guyton, McClain, Williams ineligible, to approve continuing the services.
- e) Approval of a Neighborhood Purposes Grant of \$500 to the LA Police Foundation to support National Night Out at Southeast Division on August 5: The funds will help support the purchase of backpacks to give out to children attending the event. It was moved by Marvin Bell, seconded by Barbara Tyson-Frazier, and passed 11(Bell, Cooper-Pace, Jackson, Jacobs, Johnson, Mays, Powell, Preston, Nixon, Robinson, Tyson-Frazier-1(Trejo)-0, with Bidlingmeyer, Guyton, McClain, Williams ineligible) to approve the NPG.
- f) Approval of holding a Board Retreat on Sat. August 2 from 9:30 am to 2 pm, with expenditures of no more than \$800: It was moved by Rosalie Preston, seconded by Marvin Bell, and passed 12(Bell, Cooper-Pace, Jackson, Jacobs, Johnson, Mays, Powell, Preston, Nixon, Robinson, Trejo, Tyson-Frazier)-0-0 to approve holding a Board Retreat on Sat. October 18, 2025, at 555 W. Redondo Beach Blvd., Room 185.

4) Reports

Mayor Karen Bass: Manager of Community Engagement Representative Jocelyn Dominguez explained that Mayor Bass is organizing a number of community clean up/beautification events on the last Saturday of each month. On July 26, one will be held at 256 W. 117th Street in the Harbor Gateway North area. Harbor Gateway North will have a table there. In regards to the ICE raids in the Los Angeles area, the City of Los Angeles has filed legal action against the Trump Administration as part of its actions to keep all Angelenos safe.

9) Board business/announcements

a) Reports from Committees: The Planning and Land Use Committee is continuing to work on a comment letter for the proposed six-story apartment building at 11516 S. Vermont Avenue. There are two appeals of the City Planning Commission approval of the Prologis warehouse project for the northeast corner of Vermont Avenue and Redondo Beach Blvd., which will be heard before the City Council's PLUM Committee later this fall.

b) Brief announcements from Board members: The next General membership meeting will be held on Tues. July 22 at 555 W. Redondo Beach Blvd. in Room 185. It was suggested that Caltrans be invited as a speaker.

Harbor Gateway North Neighborhood General Membership Meeting

- 1) Welcome/call to order/Board roll call: Chairperson Joan Jacobs called the meeting to order at 7:05 p.m. The roll call determined that a quorum was present.
- 2) Caltrans explains how to report over-grown vegetation, graffiti, homeless encampments, etc. on their properties: Maria Raptis, Government Affairs Office for Caltrans (maria.raptis@dot.ca.gov; 213-897-7563), and Staff Services Manager I Doug Asher (douglas.asher@dot.ca.gov) recommended best practices for obtaining services from Caltrans. The first step is to use the Customer Service Request portal for Caltrans: https://csr.dot.ca.gov

This can be used to report illegal dumping on the sides of the freeway, litter along the highway, homeless encampments, signals out along the freeway, lights out on highways, graffiti on freeway walls, etc. The online CSR will be reported and routed to the correct office. Among service requests, roadway emergencies have priority. You can also report Caltrans issues through your Council District office. There is no app yet for the Customer Service Requests and no ability to upload photos. CSR can take ten days to get to the right office. Graffiti removal takes about 7 to 10 days, unless there is offensive wording. For encampments, two weeks of outreach are scheduled with California Highway Patrol present. Then those living in the encampment are given two days' notice of the clean up. For any sign of machetes, guns, or fires related to encampments on Caltrans property, call 911.

(Arvie Powell entered the meeting at 7:19 p.m.)

Regarding lights out under freeway overpasses, if the light shines onto a City street, then it is the City's responsibility to repair it. However, if the wiring to the light belongs to Caltrans, then the lighting will be repaired by Caltrans. Just for July 2025, they are working on 256 requests. Caltrans has spent \$112,000 on repairing fencing along Union Pacific railroad tracks in the last year.

3) General public comment on non-agenda items that are within the Neighborhood Council's subject matter jurisdiction: District 5 stakeholder Jacqueline Marrero said that she is a Board member of the Athens Boulevard Block Club. Their neighborhood is dealing with a proposed apartment building of 50 units with no parking at 700 W. 120th Street, at Hoover Street. This will create an adverse impact to their community. Their Block Club has hired a legal team to file an injunction to stop the demolition of the single-family home on the site, with an August 11 court date. She is hopeful that the HGNNC can support their efforts.

District 6 stakeholder Charles Doakes expressed concern that LAPD is accepting military equipment. He also discussed how globalization is dwarfing America's right to have control over local jurisdictions and neighborhoods. Hedge funds are backing apartment developments, such as the one previously mentioned. Reverse mortgages often lead to foreclosures.

4) Reports

a) LAPD: Senior Lead Officer Tyson Hamaoka said that for issues along railroad tracks within 30 feet of the rails, then Union Pacific needs to be contacted. There was a homicide on July 19 in the 600 block of 126th Street. There was a robbery at gunpoint at 120th Street and Figueroa. There was a shooting at

- 427 W. El Segundo Street, at Figueroa near a tobacco shop. The suspect is part of the Athens Park Bloods. For any issues in Senior Lead Officer Robert Martinez's area while he is away, stakeholders can contact Officer Hamaoka.
- b) Council District 15: Field Deputy Rudy Martinez said that if stakeholders need assistance with issues on Caltrans property, forward the CSR requests to him and he will follow up with Caltrans and the relevant State Assemblymember's office. Slurry sealing of local streets will begin next week, including Hoover Street from 158th to 159th, Orchard Councilmember Tim McOsker is advocating for scheduling Redondo Beach Blvd. for pavement repair. CARE+ operations are scheduled on a bi-weekly basis along 117th Street and also Estrella north of 135th Street. They are also scheduled for problem alleys, when pointed out to the office. Three RVs were removed from Vermont Avenue at 162nd Street in front of an AT&T building. Signs saying "no parking from 2 a.m. to 6 a.m. will be posted in front of 17200 S. Vermont Avenue, another AT&T building. Figueroa from El Segundo to 120th Street has been repaired. Report issues via 311 and then follow up with Rudy if no result or a slow result. There was a suggestion for more education on using 311 to report illegal dumping and for residents to know that there is no limit to using 311 to dispose of unwanted items during weekly pick ups. District 8 stakeholders mentioned the difficulty of getting trees removed that have lifted sidewalks and created unsafe passages for those walking with canes or in wheelchairs.
- c) Mayor Karen Bass: Jocelyn Dominguez, Mayor Bass's office, commented that for sidewalks needing repairs so that seniors or the disabled can use them, report to the Office of Disability, though the repair can still take 4 to 6 years for repairs. She reminded those present that Shine LA on July 26 will include a location in Harbor Gateway North at 256 W.117th Street, between Broadway and Main Street.
- 5) Discussion: HGNNC Annual Assessment for 2024-2025 and preliminary discussion of plans for community engagement events/community improvement goals for the 2025-2026 fiscal year: Copies of the HGNNC Annual Assessment were available for those attending the meeting. Due to time constraints, a beginning discussion of plans for the 2025-2026 fiscal year was postponed to the Sat. July 18 Board Retreat. However, stakeholders were encouraged to review the Assessment and call or email in suggestions for the new fiscal year.

6) Administrative motions

- a) Approval of up to \$300 for a retractable banner for outreach events: It was moved by Marvin Bell, seconded by Alonzo Williams, and passed 8(Bell, Jackson, Jacobs, Mays, Powell, Preston, Robinson, Trejo)-0-0, with McClain and Williams ineligible, to approve the expenditure.
- b) Support for Know Your Rights training (presented via Zoom on Thurs. July 31 at 6 pm) by the Reseda Neighborhood Council in partnership with Public Counsel, with inclusion of HGNNC logo on the flyer and advertising to our stakeholders: It was moved by Rosalie Preston, seconded by Jackie Jackson, and passed 8(Bell, Jackson, Jacobs, Mays, Powell, Preston, Robinson, Trejo)-0-0, with McClain and Williams ineligible, to approve support for the training.

The meeting was adjourned at 8:44 p.m.

In the heading of this letter, we indicated whether you must file an annual information return. If a return is required, you must file Form 990, 990-EZ, 990-N, or 990-PF by the 15th day of the fifth month after the end of your annual accounting period. IRC Section 6033(j) provides that, if you don't file a required annual information return or notice for three consecutive years, your exempt status will be automatically revoked on the filing due date of the third required return or notice.

MOTION

Donald Shoup, a professor of urban planning at UCLA for 50 years, died on February 6, 2025. Shoup authored the landmark 2005 book <u>The High Cost of Free Parking</u>. His academic research and writing focused on the issue of parking and how arbitrarily-created, government-imposed minimum parking requirements both drive up the cost of development and result in cities that are oriented toward cars rather than people.

This results in unsafe streets and increased traffic deaths and injuries; buildings surrounded by parking lots instead of compact, walkable commercial districts; and more expensive housing.

Shoup's work has led many local governments to change their parking policies. It would be a fitting legacy for Los Angeles—the place where Donald Shoup spent his career—explore the feasibility of eliminating parking minimums for changes of use and for new development.

To be clear, Shoup did not contend that new development should not provide parking. Rather, he demonstrated that governments are ill-equipped to determine how many parking spaces a business actually needs; that parking requirements embedded in most zoning codes were either derived from studies at a handful of suburban or rural locations where virtually every visitor has no choice but to drive, thus overstating parking demand in areas where people have other travel options, or simply copied from another jurisdiction. For example, the City of Los Angeles requires five times as much parking for a gym than it does for a yoga studio; and twice as much parking for an art gallery than for a barber shop. Our parking requirements are not rational.

Shoup concluded that the people who develop properties and the institutions that finance development—who are literally deeply invested in the economic success of the properties, *i.e.*, their ability to rent apartments or commercial space—are best positioned to determine how much parking a project should provide.

More than 3,000 cities have adopted at least some of Shoup's suggested parking reforms, including Los Angeles. In response to the COVID pandemic, the City adopted the Emergency Ordinance, which promotes adaptive reuse of existing buildings by allowing changes of use without triggering additional parking requirements. This has worked well for both businesses and their customers, and has not had adverse impacts on neighborhoods.. Through legislation such as AB 2097, the State of California has eliminated parking requirements near major transit stops. However, many cities have gone beyond Los Angeles and eliminated parking requirements citywide, including San Francisco, San Jose, and Sacramento.

While it is true that <u>most</u> people in Los Angeles own cars and drive, it is not true that <u>everyone</u> does so. According to the American Community Survey, there are approximately 770,000 households in Los Angeles with zero or only one vehicle, more than half of all households. There are approximately 480,000 single-person households in the City of Los Angeles (31.5% of the total), who are unlikely to need more than one vehicle. Self-driving vehicles already provide transportation from Downtown to the ocean, and will continue to proliferate, reducing the need for personal vehicles. However, our standard parking requirements are based on the flawed assumption that nearly every household has at least two cars; and that everyone drives for nearly all of their trips. Just as we allow people to select how many

bedrooms and bathrooms they want in the apartments they rent, we could allow them to select how many parking spaces they need.

Moreover, Los Angeles suffers from a severe housing affordability crisis. One of Shoup's most important contributions to the public discourse on parking requirements was to highlight just how much parking spaces can cost. Underground parking can cost more than \$50,000 per space to construct, and thus can add more than \$100,000 to the cost of a housing unit. We must find ways to reduce the cost of constructing new housing, and eliminating parking requirements is one way to do so. It bears repeating that those who construct new housing have every incentive to rent (or sell) that housing, and will provide the amounts of parking necessary for them to do so.

Brick-and-mortar retail stores and restaurants struggle to keep their doors open, due to economy-wide shifts toward on-line shopping and delivery services as well as local ordinances and policies. Amazon is not required to provide parking for its delivery vehicles that flood many of our neighborhoods, and neither are pop-up restaurants that operate under our sidewalk vending rules. We should level the playing field to support local businesses and neighborhood commercial districts.

Although State laws such as AB 2097 preclude the City from imposing parking requirements in areas near major transit stops, a citywide approach offers advantages. The routes and frequency of transit service can shift over time, which can be due to fiscal challenges at Metro or other transit providers rather than a change in demand. Instead of requiring a determination from Planning or Building & Safety about whether AB 2097 or some other exemption applies at some point in the process, a developer can—from the start—design a project based on its actual parking needs. In short, a citywide rule ensures consistency and predictability.

I THEREFORE MOVE that the Department of City Planning, in consultation with the Department of Building & Safety, be INSTRUCTED to report with recommendations regarding the feasibility and cost-benefit analysis of citywide elimination of off-street parking requirements for new development and changes of use.
