- 1) Welcome/call to order/Board roll call: Due to Vice Chair Joan Jacobs being a candidate, At-Large Representative Craig Kusunoki announced that since he is not a candidate, he would be chairing the meeting. He called the meeting to order at 7:05 p.m. The roll call determined that a quorum was present.
- 2025 HGNNC Board Election Candidate Forum conducted by the League of Women Voters of Torrance Area including Gardena, Carson, Harbor City, and Lomita: Gloria Gutierrez, President of the League of Women Voters of Torrance Area, introduced herself and then introduced Ryan Rauzon. Director of Communications for the League. Each candidate was then allowed two minutes to introduce themselves. Then for the four contested seats (Chairperson, District 5 Representative, District 6 Representative, and At-Large Representative) each candidate was asked what they see as the two top issues facing the Neighborhood Council.
